## <u>CMRL-SPONSORED "PG DIPLOMA COURSE IN METRO RAIL TECHNOLOGY AND</u> <u>MANAGEMENT" AT IIT MADRAS</u>

Chennai Metro Rail Limited (CMRL), a Joint Venture of Govt. of India and Govt. of Tamil Nadu, is a special purpose vehicle (SPV) entrusted with the responsibility of implementing the Metro Rail Project in the city of Chennai.

Applications are invited from dynamic and result oriented engineering graduates in Civil, Electrical, Electronics & Communication, Electrical & Electronics and Mechanical for CMRL sponsored "PG Diploma Course in Metro Rail Technology and Management" (PGDMRTM). The total number of posts is 18.

## **1. Discipline codes and distribution of posts:**

**<u>2. Age:</u>** Not more than 28 years as on **09.06.2024** (Relaxation by 3 years for OBC(NCL) and 5 years for SC/ST).

Persons with Disability shall be eligible for an age concession up to ten years over and above the age limits prescribed, provided the applicant is otherwise fully suitable and the disability is not such as would render the applicant incapable of efficiently discharging the duties w.r.t post for which the candidate is selected.

**<u>3.Educational Qualification</u>**: First class graduates with a minimum aggregate average of 70% marks \* (relaxation by 5% for SC/ST candidates) in Civil / Electrical /Electronics and Communication / Electrical and Electronics / Mechanical Engineering from a recognized University/Institute as approved by AICTE/ UGC are eligible to apply. The candidates should have a valid GATE score at the time of applying. Final year students who will secure the eligible degree before the commencement of the course can also apply.

\* CGPA will be converted to percentage marks as per IIT M senate norms.

**<u>4.Selection Process</u>**: The provisional selection is based on the valid GATE score and interview. The final selection will be subject to medical fitness.

**5.** Stipend & Contract period: Candidates on final selection will be designated as Executive Trainees during the course period of one year with a stipend of Rs.30,000 /- per month, and CMRL will bear the necessary sponsorship and tuition fees for perusing PGDMRTM at Indian Institute of Technology Madras (IIT M).

On successful completion of the course, the trainees will be posted as Assistant Manager on contract for a period of 5 years in Chennai Metro Rail Ltd with a consolidated pay of Rs.62,000/- p.m. Candidates who excel during the course and secure a CGPA of 8.5 or more will be granted two advance increments upon joining, while others will be granted one advance increment.

On completion of 05 years of service as Assistant Manager, the contract may further be extended based on project requirements and performance of the candidate. Permanent absorption may also be considered based on the project requirements, performance, eligibility criteria and other extant rules of CMRL HR policy.

**<u>6.Bond Period</u>**: Before joining the course, the selected candidates will have to execute a bond of Rs.6 Lakhs to serve Chennai Metro Rail Limited for a period of six years, including the PG Diploma course period of one year.

Candidates who fail to qualify / complete the course will not be posted in Chennai Metro Rail Limited and they will have to pay a bond amount of Rs.6 Lakh to Chennai Metro Rail Limited for the training cost. Those Trainees who successfully complete the course but do not join Chennai Metro Rail Limited within ten days of completion of the course, their candidature will lapse, and they will also have to pay a bond amount of Rs.6 Lakh to Chennai Metro Rail Limited.

#### 7. Payment of application fee via NEFT / UPI (Non-refundable fee):

- b) No application fee for Persons with Disability. Only the disability certificate is to be uploaded online in the application.
- c) The Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility and time limit before paying the application fee.

#### 8. <u>How to Apply through Online & other instructions:</u>

a. Before applying, candidates are advised to read the advertisement carefully and ensure that they fulfil all the eligibility criteria. Their eligibility is provisional and the same will be verified only in case they are shortlisted for selection. #### b. Step by step procedure to apply online.

**Step 1** – The Candidate must register in the CMRL Career portal by using a valid email ID. The email ID registered in the portal will only be used for any further correspondence from CMRL.

**Step 2** - A registration link will be sent to the candidate's registered email ID. Therefore, candidates are required to click the verify button to authenticate their email ID. Upon verifying, the user will be redirected to the CMRL career page to log in and apply.

Step 3 – Candidates must fill in all details in each section and make sure to upload the requisite documents as per the notification, wherever applicable, to authenticate the details mentioned in the application form.
